TERMS & CONDITIONS

CANCELLATION POLICY:

◆ CANCELLATIONS MADE ON OR BEFORE APRIL 30, 2010 WILL BE ASSESSED \$150 PER PERSON, PLUS \$150 PER PERSON ADMINISTRATIVE FEE AND NON-REFUNDABLE INSURANCE.

◆ CANCELLATIONS MADE BETWEEN MAY 1 AND AUGUST 1, 2010 WILL BE ASSESSED \$300 PER PERSON PLUS ADMINISTRATIVE FEE AND NON-REFUNDABLE INSURANCE.

◆ CANCELLATIONS MADE BETWEEN AUGUST 2 AND AUGUST 19, 2010 WILL BE ASSESSED \$900 PER PERSON PLUS ADMINISTRATIVE FEE AND NON-REFUNDABLE INSURANCE.

◆ CANCELLATIONS MADE BETWEEN AUGUST 20 AND SEPTEMBER 17, 2010 WILL BE ASSESSED 50% OF THE TOTAL COST INCLUDING AIRFARE, HOTEL & LAND CHARGES PLUS ADMINISTRATIVE FEE AND NON-REFUNDABLE INSURANCE.

_ CANCELLATIONS MADE BETWEEN SEPTEMBER 18 AND SEPTEMBER 30, 2010 WILL BE ASSESSED 75% OF THE TOTAL COST INCLUDING AIRFARE, HOTEL & LAND CHARGES PLUS ADMINISTRATIVE FEE AND NON-REFUNDABLE INSURANCE.

◆ A 100% CANCELLATION FEE WILL BE ASSESSED FOR ANY CANCELLATION RECEIVED BETWEEN OCTOBER 1 AND OCTOBER 17, 2010 INCLUDING "NO SHOWS".

PLEASE NOTE: PRINCESS CRUISES AIRLINE RESERVATIONS CANCELED OR CHANGED AFTER AIRFARE IS PAID IN FULL WILL BE ASSESSED A \$75 PER PERSON FEE, PLUS ANY CANCELLATION FEES IMPOSED BY THE AIRLINE. AIRLINE TICKETS ARE BASED ON FARES WHICH ARE HIGHLY RESTRICTIVE AND OFTEN CANNOT BE REISSUED OR EXCHANGED FOR ANOTHER CARRIER OR ROUTING. CANCELED HOTEL RESERVATIONS WILL BE ASSESSED A PENALTY DETERMINED BY THE CRUISE LINE.

NAME CHANGES:

NAME CHANGES FOR THE CRUISE REQUIRE THE PRIOR APPROVAL OF PRINCESS CRUISES AND MAY NOT ALWAYS BE POSSIBLE. NAME CHANGES ARE CONSIDERED RESERVATION CANCELLATIONS AND ARE SUBJECT TO CANCELLATION FEES DETERMINED BY THE CRUISE LINE, PLUS ADDITIONAL FEES FOR TICKETING AND MAILING. A NAME CHANGE MUST BE SUBMITTED IN WRITING AND MAY BE CHARGED THE RATE CURRENTLY IN EFFECT.

CHANGE FEES:

CHANGING YOUR ITINERARY AFTER RESERVATIONS HAVE BEEN MADE CAN RESULT IN LOSS OF ADVANTAGES GAINED BY EARLY PLANNING. IF YOU REQUEST A "CHANGE" IN YOUR TRAVEL ARRANGEMENTS, PRINCESS CRUISES WILL CHARGE A PER PERSON CHANGE FEE, PLUS ANY FEES IMPOSED BY THE AIRLINES OR HOTELS AND KELLY CRUISES WILL CHARGE A \$50 PER PERSON ADMINISTRATIVE FEE PER CHANGE. CHANGES REFER TO CRUISE, AIR TICKETS AND HOTEL RESERVATIONS INCLUDING NAME SUBSTITUTIONS, CORRECTIONS AND SPELLINGS AND ARE SUBJECT TO THE RATES, CANCELLATION FEES AND BOOKING CONDITIONS IN EFFECT AT THE TIME OF THE CHANGE.

THE CONFERENCE RATE INCLUDES A 12 DAY CRUISE AND CONFERENCE FEES. PLEASE NOTE: THESE RATES ARE NEGOTIATED, CONTRACTED RATES AND ARE NOT COMBINABLE WITH ANY OTHER PRINCESS CRUISES PROMOTIONAL OFFER, CERTIFICATE, VOUCHER OR PAST PASSENGER SPECIAL.

TRAVEL INSURANCE:

WE WANT YOU TO FEEL SAFE AND BE SECURE WHEN YOU TRAVEL. FOR THIS REASON, TRAVEL INSURANCE IS MANDATORY FOR THE CONFERENCE GROUP CRUISES AND MUST BE PAID WITH DEPOSIT. TRAVEL GUARD INTERNATIONAL INSURANCE OFFERS THE MOST COMPREHENSIVE PACKAGE THAT INCLUDES COVERAGE FOR PRE-EXISTING MEDICAL COVERAGE, TRIP CANCELLATION AND INTERRUPTION FOR SELECT COVERED REASONS, TERRORIST INCIDENTS IN A CITY TO WHICH YOU WERE SCHEDULED TO ARRIVE WITHIN 30 DAYS, FINANCIAL DEFAULT OF AIRLINE, CRUISE LINE OR TOUR OPERATOR RESULTING IN THE COMPLETE CESSATION OF SERVICES, MISSED CONNECTION, TRAVEL DELAY, BAGGAGE DELAY, EMERGENCY MEDICAL TRANSPORTATION PLUS MEDICAL EXPENSES. DETAILS ON THE COMPLETE INSURANCE PACKAGE WILL BE MAILED TO YOU WITH YOUR INVOICE.

INSURANCE PREMIUMS ARE NON-REFUNDABLE/NON-TRANSFERABLE AND ARE INCLUDED IN THE REQUIRED DEPOSIT. THE PREMIUM WILL BE ADJUSTED AND IS DEPENDENT ON TOTAL TRIP COST (CRUISE, AIRFARE, TAXES, PACKAGES, ETC.). IT MAY INCREASE IF OPTIONAL LAND PACKAGES, CABIN UPGRADES, AIR UPGRADES OR ETC. ARE PURCHASED.

PLEASE NOTE: THE POLICY DOES NOT COVER LOSS CAUSED BY ACT OF WAR, MILITARY DUTY OR SERVICE. AN ACT OF WAR (DECLARED OR UNDECLARED) IS NOT AN INSURABLE RISK AND IS A GENERAL EXCLUSION ON ALL INSURANCE PRODUCTS (HOME, HEALTH, LIFE, AUTO, TRAVEL, ETC.).

FLIGHT CHOICE PROGRAM:

PRINCESS CRUISES OFFERS ECONOMY CLASS AIR TRANSPORTATION FROM OVER 100 MAJOR GATEWAY CITIES. THE CRUISE LINE RESERVES THE RIGHT TO CHOOSE THE AIR CARRIER ROUTING AND CITY AIRPORT FROM EACH GATEWAY CITY AND RESERVES THE RIGHT TO SUBSTITUTE CHARTER OR COMMUTER FLIGHTS FOR SCHEDULED AIR SERVICE WITHOUT PRIOR NOTICE. AIRFARES USED ARE BASED ON CAPACITY CONTROLLED AS WELL AS CONTRACT, NON-REFUNDABLE AND GROUP FARES. AIRFARES DO NOT INCLUDE PASSENGER FACILITY CHARGES ASSESSED BY AIRPORTS OR INTERNATIONAL ARRIVAL & DEPARTURE TAXES. FUEL AND AIR SURCHARGES WILL BE APPLIED WHEN APPLICABLE. PRINCESS CRUISES OFFERS A **FLIGHTCHOICE** PROGRAM TO HANDLE SPECIAL REQUESTS SUCH AS NON-STOP FLIGHTS; SPECIFIC AIRLINES, FLIGHTS OR TIMES; UPGRADES TO BUSINESS OR FIRST CLASS; EXTENDED, EARLY OR LATE FLIGHT SCHEDULES. REQUESTS MUST BE RECEIVED IN WRITING BY KELLY CRUISES AT THE TIME OF BOOKING OR NO LATER THAN JUNE 1, 2010. FOR ACCEPTED REQUESTS, THERE WILL BE A \$75 PER PERSON NON-REFUNDABLE SERVICE CHARGE PLUS ANY ADDITIONAL AIRLINE CHARGES. A \$75 FEE WILL BE CHARGED FOR EACH ADDITIONAL REQUEST OR CHANGE THEREAFTER. ALL DEVIATIONS ARE SUBJECT TO AVAILABILITY AND CONFIRMATION.

IF YOU ARE PLANNING ON MAKING YOUR OWN AIR ARRANGEMENTS, PLEASE CONTACT KELLY CRUISES TO VERIFY THE CRUISE LINE'S DEPARTURE AND ARRIVAL TIMES IN ROME. WE RECOMMEND YOU SCHEDULE A MINIMUM OF FOUR HOURS AT THE BEGINNING AND THE END OF THE CRUISE TO ALLOW FOR TRANSFERS, CUSTOMS AND AIRPORT SECURITY CHECKS.

AIRPORT TRANSFERS:

PRINCESS CRUISES OFFERS AIRPORT TO PIER/PIER TO AIRPORT TRANSFERS IN ROME FOR \$138 PER PERSON ROUNDTRIP AS LONG AS YOU ARE ARRIVING AND DEPARTING ON THE SHIP'S TURNAROUND DAYS. IF YOU ELECT NOT TO PURCHASE THE TRANSFERS, YOU WILL BE FULLY RESPONSIBLE FOR YOUR OWN TRANSPORTATION. THE PORT FOR ROME IS CIVITAVECCHIA, APPROXIMATELY A TWO HOUR TRANSFER FROM ROME. BE SURE TO ALLOW EXTRA TRAVEL TIME.

DEPOSITS:

A \$1200 PER PERSON DEPOSIT IS REQUIRED TO REGISTER ALONG WITH THE COMPLETED RESERVATION FORM. THE NON-REFUNDABLE INSURANCE PREMIUM IS INCLUDED IN THE REQUIRED DEPOSIT.

DOCUMENTATION:

INVOICES AND INFORMATION PACKETS WILL AUTOMATICALLY BE SENT TO YOUR CREDIT UNION. REQUESTS TO HAVE DOCUMENTATION MAILED DIRECTLY TO A HOME ADDRESS REQUIRE A LETTER OF PERMISSION FROM THE CREDIT UNION. PRINCESS DOES NOT PRINT HARD COPY DOCUMENTS. ONCE YOUR BOOKING HAS BEEN MADE, YOU'LL BE ABLE TO VIEW YOUR BOOKING INFORMATION ONLINE AT WWW.PRINCESS.COM. WITH PRINCESS' ETICKET PROGRAM, YOU CAN PRINT YOUR CRUISE DOCUMENTS, TRAVEL SUMMARY AND BOARDING PASS ONLINE. FURTHER INSTRUCTIONS WILL BE PROVIDED.

FINAL PAYMENT:

FINAL PAYMENT IS DUE **JULY 20, 2010**

NON-DISCOUNTABLE AMOUNTS, GOVERNMENT TAXES & FEES AND FUEL SUPPLEMENTS ARE ADDITIONAL AND WILL BE INCLUDED ON YOUR INVOICE. ALL TAXES & FEES ARE SUBJECT TO INCREASE.

TRAVEL DOCUMENTS: ALL GUESTS ARE REQUIRED TO CARRY A **U.S. PASSPORT VALID FOR 6 MONTHS AFTER DISEMBARKING THE SHIP.** EXPIRED PASSPORTS ARE NOT ACCEPTABLE. IN ADDITION, NON-U.S. CITIZENS WHO HAVE PREVIOUSLY BEEN ADMITTED TO THE UNITED STATES FOR PERMANENT RESIDENCE MUST CARRY THEIR PERMANENT RESIDENT CARD (GREEN CARD).

NEW! TRANSPORTATION SECURITY ADMINISTRATION REQUIREMENTS (TSA). AIRLINE PASSENGER TRAVEL DOCUMENTS MUST BE AN EXACT MATCH TO PASSENGER IDENTIFICATION DOCUMENTS.

TSA SECURE FLIGHT PROGRAM REQUIRES THE COLLECTION OF FULL PASSENGER NAMES AT THE TIME YOU BOOK AN AIRLINE RESERVATION. THE PASSENGER NAMES COLLECTED MUST BE AN EXACT MATCH TO THE IDENTIFICATION DOCUMENTS THE PASSENGER INTENDS TO USE WHEN TRAVELING.

IN SOME CASES, A PASSENGER'S FULL NAME MIGHT APPEAR DIFFERENTLY ON THE PASSENGER'S VARIOUS IDENTITY DOCUMENTS. IN THIS CASE, PLEASE ENSURE THE DATA PROVIDED WHEN MAKING THE RESERVATION EXACTLY MATCHES THE DOCUMENT THE PASSENGER WILL USE FOR IDENTIFICATION PURPOSES AT CHECK-IN.

EXAMPLE: PASSENGER'S FULL NAME IS JOHN ROBERT SMITH, YET HIS DRIVER'S LICENSE STATES JOHN SMITH; HIS RESERVATION SHOULD BE MADE AS JOHN SMITH. IF PASSENGER INTENDS ON USING HIS PASSPORT WHICH READS JOHN ROBERT SMITH; HIS RESERVATION SHOULD BE MADE AS JOHN ROBERT SMITH. PLEASE ENSURE THAT THE FULL NAME GIVEN ON THE CONFERENCE RESERVATION FORM MATCHES YOUR PASSPORT. YOUR CRUISE AND AIRLINE TICKET WILL REFLECT THAT NAME. NON-U.S. CITIZENS WILL BE RESPONSIBLE TO CHECK WITH THEIR CONSULATES TO DETERMINE THE DOCUMENTATION REQUIREMENTS FOR THE COUNTRIES TO BE VISITED.

SPECIAL NOTE: EVERY EFFORT HAS BEEN MADE TO PRODUCE ACCURATE INFORMATION. KELLY CRUISES RESERVES THE RIGHT TO PASS ALONG ANY CHANGES IN POLICY ADMINISTERED BY PRINCESS CRUISES RELATING TO ANY ASPECT OF YOUR CRUISE SINCE THE PUBLICATION OF THIS TERMS & CONDITIONS STATEMENT. CRUISE LINE SPECIAL CABIN REQUESTS WILL BE FORWARDED TO THE CRUISE LINE, BUT WE ARE UNABLE TO GUARANTEE THEM.

RESPONSIBILITY:

THE CONFERENCE GROUP AND KELLY CRUISES HEREAFTER REFERRED TO AS THE SPONSOR AND THE AGENT, ACT AS AGENTS FOR PRINCESS CRUISES, ACCOMMODATIONS, TRANSPORTATION AND AIRLINES ENGAGED IN CARING FOR AND SERVICING TRIP PASSENGERS. KELLY CRUISES AND THE CONFERENCE GROUP WILL NOT BE RESPONSIBLE FOR ERRORS IN MISS-INFORMATION PROVIDED TO THEM BY THE CRUISE LINE, AIRLINES, HOTELS OR TRANSPORTATION COMPANIES. THE SPONSOR AND THE AGENT WILL NOT BE HELD FINANCIALLY LIABLE FOR THE FAILURE OF A TRAVEL SUPPLIER TO COMPLETELY PROVIDE THEIR SERVICES WHETHER DUE TO DELAY OR CHANGES IN SCHEDULE, OVERBOOKING OF ACCOMMODATIONS, WEATHER, LABOR PROBLEMS, MECHANICAL ISSUES, TERRORISM, DISEASES, POLITICAL UNREST, GOVERNMENTAL RULINGS, ACTS OF WAR, CARELESS ACTIONS, CESSATION OF SERVICES, CRIMINAL ACTIVITY, ANY OTHER CAUSE BEYOND ITS CONTROL INCLUDING CANCELLATIONS OR DELAYS RESULTING FROM INVALID PASSPORTS, VISAS OR OTHER TRAVEL DOCUMENTATION REQUIREMENTS.
